History

1997/January 1998: DFG (German Research Foundation) publishes 16 recommendations of the Professional Self Regulation in Science

<u>September 1998</u>: Helmholtz Association of German Research Centers decides on 4 rules on the basis of the DFG-recommendations

May 1999: DESY-directorate accepts recommendations of a committee and to submit them to the Scientific Council, the Scientific Committee and later to the Administrative Council

October 2001: nomination of four Confidential Representatives (two of Hamburg, two of Zeuthen) by the directorate

October 2006: on account of criticism of the DFG on the DESY rules of 1999 revison of the DESY rules leading to the actual version





Most important changes

•Rule 1:

Implementing of new version of the DFG-recommendation 6 (quality takes priority of quantity)

•Rule 3:

Obligation to preserve primary data for 10 years (DFG-recommendation 7)

•Rule 4:

Confirmation of the Confidential Representatives by the Scientific Council and the Scientific Committee

•Rule 4:

Implementation of concret procedural steps in case of scientific misconduct (DFG-recommendation 8)







Next Steps

Status Quo:

Confidential Representatives (C.Spiering, A.Schwarz, T.Naumann, H.Franz)
have agreed to stay in charge of their duty until the passing of the new version
of DESY rules and a new appointment by the directorate during the first quarter
of 2007

Procedure:

- Agreement of the rules by Scientific Council, October 2006
- Agreement of the rules by Scientific Committee, November 2006
- Confirmation of the rules by Administrative Council, November 2006
- New appointment of four Confidential Representatives by the directorate of DESY, beginning of 2007
